# Data protection



**COLEGIO MAYOR OLARAIN, S.L.**  
(Hereinafter “**OLARAIN**”) expressly informs you that:

01. Personal information provided shall be incorporated into our data sheets used to manage the School’s organisational and administrative tasks, as well as for all other purposes derived from the Statutes, the centre’s Internal Regulations, and the business hours and criteria in effect at all times.
02. OLARAIN has video surveillance equipment installed in various premises, as well as outside its buildings. Your image may therefore be included in the “Closed Circuit Television Sheet”, with the purpose of providing proper attention and security to residents, workers, and third-parties, and the facilities and activities of the entity itself.
03. OLARAIN has access control systems based on the use of electronic cards. The use of your electronic card may therefore be included in the “Premises Access Sheet”, with the purpose of providing adequate access control to the School’s facilities, and management of incidents derived thereof.
04. Its handling shall be carried out in accordance with laws in effect at all times regarding the Protection of Personal Data.
